INFORMATION ABOUT THE PROCESSING OF PERSONAL DATA

2. Purpose of the processing and the legal basis for processing:

The controller processes the following personal data during the online ticket sale for cultural and leisure events at www.obsceneextreme.cz: title, name, surname, telephone and e-mail addresses. The controller is authorised to process the personal data on the basis of contractual performance as it is necessary to identify and contact you. The email address is used to send the tickets to you and the telephone number to contact you if any organizational changes need to take place just before the event and any other means of communication would not be fast and effective enough. In the course of the event photographs can be taken to document it, based on the legal title of public interest, which consisits in the execution of the reporting license and informing the public about the social and cultural events in the locality.

3. The recipients or categories of recipients of the personal data and, where applicable, the intention to transfer the data to a third country:

Personal information may only be randomly accessed by the company that manages the system through which the online ticketing occurs. This company does not process the personal data but it can, only in the case of service activities and system fixes, see the data. This is in particular the company TIKETBOX, s. r.o. nám. Františka Křižíka 1879/19, 390 01 Tábor, IČO: 05817650. The personal data is not passed on to anyone else.

- 4. Retention time for the personal data: The seller keeps track of all purchasers' data for an indefinite period and uses it for the purpose of sending business communication about the events. The buyer can clearly tick a check box on sign-up that he or she does not want to be sent any commercial messages (then all his or her data is deleted after the event he or she purchased the tickets for). If the buyer does not want to be sent any commercial messages afterwards, he or she can cancel their sending simply by an e-mail reply stating that he or she does not want to receive any business messages; in this case, his or her personal data is deleted after the end of the event which he or she bought the tickets for. The buyer may also contact the seller directly to disagree with the commercial communication.
- 5. You have the right to request the access, rectification or deletion of your personal data from the controller, or the right to request processing restrictions and the right to object to processing, as well as the right to data portability. Your requirements will always be properly assessed and settled in accordance with the applicable GDPR and related legislation.
- 6. You have the right to file a complaint with the supervisory authority if you think the GDPR rules would be violated by the processing of your personal data.
- 7. You can apply your rights as outlined in paragraph 6 in the following ways:
- in writing, by postal mail to the address of the controller or authorized representative, where the signature of the subject must be officially authenticated
- by e-mail to the controller or authorized representative, where the electronic signature must be provided with a qualified certificate
- through the data box.
- 8. If the controller intends to process your personal data for a purpose other than that for which it was collected, you will always be informed about this other purpose and other relevant facts and the applicable legislation will be followed.
- 9. Your personal data is provided and protected in accordance with the directive 2016/679 of the European Parliament and the Council (EU) about the protection of natural persons with regard to the processing of personal data and the free movement of the data and the cancellation of the directive 95/46/ES and other legal rules controlling the protection of personal data.
